
CJI represents South Dakota's commitment to the adult criminal justice involved population with behavioral health needs. CJI offers quality, evidence-based services targeting substance use disorders (SUD) and criminal thinking.

CJI offers Cognitive Behavioral Interventions for Substance Abuse (CBISA), Moral Reconation Therapy (MRT), and Level 3.1 Clinically-Managed Low-Intensity Residential Services. Additionally, CBISA and MRT are offered via telehealth to serve clients unable to access services through traditional means.

CJI is a collaboration between the Department of Social Services (DSS), Unified Judicial System (UJS), Department of Corrections (DOC), and community agencies.

Carroll Institute (CI) provides CBISA and Level 3.1 Clinically-Managed Low-Intensity Residential Services in the Second Judicial Circuit to CII funded clients.

This profile page reflects CJI publicly funded clients in FY19, which runs from June 2018-May 2019.

Impact of treatment services is measured by surveying client perception of the quality of services received including the following: general satisfaction with services, access to services, quality and appropriateness of services, outcome of services, and participation in treatment planning. Additionally, impacts are measured by improvements in social connectedness and overall functioning. Impact of treatment services is relevant because clients who feel empowered, motivated, have positive family relationships, and feel they have the ability to change may be more likely to have positive treatment outcomes.
